Wetlands - our lifeline


Wetlands occur where water meets land. In these transitional ecosystems, the water table is usually at or near the surface, or land is covered by water permanently or seasonally. Wetlands are variously known by a number of terms such as lakes, floodplains, estuaries, marshes, swamps, fens, bogs, tidal flats, mangroves, sea-grass beds, coral reefs and even include humanmade systems such as reservoirs, salt pans, tanks and irrigation canals. Wetlands exist in every country and every climatic zone from the polar regions to the tropics and from high altitudes to dry regions.

Wetlands are sources of water, providers of a number of plants, animal and mineral products, buffer humanity against the impacts of extreme events such as floods, storms and cyclones, and serve as recreational and cultural spaces. A number of plant and animal species use wetlands as habitats. Species

such as migratory birds and fishes depend on wetlands to complete their life cycles. Wetlands provide excellent opportunities for education and research on aquatic ecosystems, and are inextricably linked with our culture and belief systems. Wetlands such as mangroves and peatlands are one of the most efficient carbon stores. A world without wetlands is a world which is water, food and climate insecure.

Despite their immense contributions, wetlands are one of the most rapidly degrading ecosystems on earth.

Concerted action by government, civil society groups, individuals, and the private sector is urgently needed to reverse this trend. Halting the degradation of wetlands and restoring these unique ecosystems is an effective way to conserve wetland-dependent species and make the society resilient and water, food and climate secure.
